Data privacy protection information from Freunde der TUM e.V. (TUM Association of Alumni and Friends)

This document provides you with information on the processing of your personal data as an association member and on your data privacy rights as set out in the General Data Protection Regulation (GDPR).

Responsibility. The responsible party within the sense of the GDPR is: Freunde der TUM e. V., c/ o BMW AG - Abt. EN-100, 80788 München, email: bund-der-freunde.tum@bmw.de.

Data Types. In addition to the details on the Declaration of Enrollment (contact details, bank details), we process the following data in particular: details on association membership (date of admission, withdrawal, notice and death; affiliation to member groups, functions in the association, honors received, and method of postal shipping), participation in events, other association activities, and correspondence with you.

Data Usage. We process your data on the start, running, and termination of the membership, and on the fulfillment of our statutory objectives. As a rule, the data is collected directly from you yourself. We will use the email address and telephone number – if provided – for membership-related correspondence (e.g. queries about invoicing or sending of invoice). You will receive further information (e.g. on events or prizes) from us via mail or, if you expressly consent, via email. Voluntary details are indicated as such. **We cannot process your membership application if you leave out mandatory details.**

Legal Basis. Unless specified otherwise (e.g. in the case of consent), the legal basis for our processes is formed by Art. 6(1)(b) of the GDPR (performance of contract for club membership).

Other Data Recipients. Within the association, the departments that require your data to perform their tasks shall be granted access to it. Outside the association, personal data is passed on as follows: a) name, possibly also images to the press for press reports or for publication on our homepage, as long as legal, b) to service providers (e.g. sending emails and fee invoicing), and c) to BMW AG, Munich, who carry out the tasks of the management office on our behalf by way of agency. We do not intend to transfer your data to a country outside the European Economic Area or to an international organization.

Period of storage. The data will be processed for as long as and to the extent that is necessary for fulfillment of the objectives. Once the data is no longer required, it is deleted on a regular basis after the end of the statutory storage period unless further processing is required to preserve proof within the framework of statutory periods of limitation. As a rule, membership-related data is finally deleted 10 years after leaving the association.

Your Rights. You have the right of access under current legal regulations (Art. 15 GDPR, Section 34 German Federal Data Protection Act (BDSG)). Also, you have rights to rectification (Art. 16 GDPR), to erasure (Art. 17 GDPR, Section 35 German Federal Data Protection Act (BDSG)), to restriction of processing (Art. 18 GDPR), and to data portability (Art. 20 GDPR). Furthermore, you have the right to lodge a complaint to a data protection supervisory authority (Art. 77 GDPR in combination with Section 19 GDPR). If you have given consent to the processing of personal data (information via email), you have the right to revoke this from us at any time. The revocation is only effective for the future.

You have the right to object to the processing of personal data concerning you that is carried out on the basis of Art. 6(1)(f) of the GDPR (processing for the purpose of legitimate interests) at any time for reasons resulting from your special situation. You also have the right to object at any time to the processing of personal data concerning you for the purpose of direct marketing.
